- (3) Thirty percent (30%)—Twenty-five percent (25%) shall be used for the provision of visitor impact services within the governmental entity imposing the tax. If the amount is collected under a tax imposed countywide, the joint powers board shall distribute the amount to the county under the same terms and conditions as provided under subdivision (III)(2) of this subparagraph, but the funds shall only be used for the purposes specified in this subdivision. As used in this section, "visitor impact services" includes, but is not limited to, provision of vehicle parking, public transportation, public restrooms, pedestrian and bicycle pathways, museums and other displays.
- (D) Beginning July 1, 1999, and adjusted annually for the percentage increase in the Wyoming cost-of-living index for the previous fiscal year as determined

by the division of economic analysis of the department of administration and information, When lodging tax revenues collected for each of the preceding three (3) fiscal years by a county, city or town imposing a lodging tax at any rate exceed five hundred thousand dollars (\$500,000.00), or if no lodging tax was imposed in any of the three (3) preceding fiscal years but, based upon sales tax collection records provided by the department of revenue, it can reasonably be presumed that at least five hundred thousand dollars (\$500,000.00) in lodging tax may be collected annually in each county, city or town imposing a lodging tax at not more than one percent (1%) any rate, the amount collected shall be distributed as provided in subdivision (a)(ii)(B)(III) of this section;".

- (i) A person who pays a tax for lodging services imposed under W.S. 39-15-104(h)(i) or (ii).
- (b) The exemption shall be an annual exemption of five dollars (\$5.00) of assessed value for each dollar paid in lodging taxes. The exemption shall apply to the tax year in which application is made for the exemption, but shall be based on lodging taxes paid in the prior tax year.

- (c) In order to receive the exemption provided by this section the claimant shall file a sworn claim on or before the fourth Monday in May with the county assessor of the county in which the property against which the exemption is sought is located indicating:
- (i) The claimant's right to the exemption as shown by documentation affirming payment of the lodging taxes;
- (ii) That the claimant is listed as an owner of the property, that the property is the subject of a trust created by or for the benefit of the claimant or that the claimant is listed as a purchaser on a valid and effective contract for deed for the property and evidence of the contract for deed has been recorded with the county clerk;
- (iii) The total tax benefit which the claimant expects to receive under this section to the best of the claimant's knowledge;
- (iv) That the exemption shall be claimed by the claimant in not more than one (1) county in this state.
- (d) Any county, city or town, school district or other political subdivision may request funding from the state in accordance with this subsection for any revenue loss caused by this section. To the extent funds are available in the Wyoming tourism reserve and projects account created by W.S. 39-15-111(p)(i)(B), the state auditor shall provide funds from the account to compensate the county, city or town, school district or other political subdivision for revenue losses attributable to tax exemptions provided by this section. In the event funds within the account are insufficient to compensate all counties, cities or towns, school districts or other political subdivisions, funds shall be provided on a proportional basis. Application shall be made to the state auditor in a manner and on forms prescribed by the state auditor. By September 1 of each year, application shall be made for the previous tax year."

- (a) All monies received by the board and office shall be deposited in the state treasury. Funds in the account are continuously appropriated to the board and office and shall only be expended for the operation of the Wyoming tourism board and the Wyoming office of tourism and to administer this article. Investment earnings on monies in the account shall be deposited to the credit of the account. Notwithstanding W.S. 9-2-1008 or 9-4-207, unexpended funds in the account shall not revert. The board and office shall report the balance of the account each fiscal year to the joint travel, recreation, wildlife and cultural resources interim committee.
- (b) The office shall collect an annual fee not to exceed five hundred dollars (\$500.00) from all tourism vendors. Fees collected by the office shall be deposited with the state treasurer and credited to the Wyoming tourism account.

- (a) Any tourism vendor who has paid any assessment as provided in this article is entitled to a prompt refund of the contribution from the board upon request. A claim for a refund shall be made to the board not less than thirty (30) nor more than ninety (90) days from the date of the payment. The claim shall be made on a form prescribed and furnished by the board.
- (b) Before processing any claim for refund under this section, the board may require any additional information or affirmation under penalty of perjury that it deems necessary to determine the validity of the claim.
