Page 3-lines 15 through 21 Delete entirely and insert:

(A) Twenty-three cents (\$.23) per mile for necessary travel and ~~not to exceed twenty dollars (\$20.00)-actual costs incurred~~ for advertising in the case of sale of personal property ~~and not to exceed twenty dollars (\$20.00) for advertising in the case of~~ or in the case of sale of real property to collect delinquent taxes, not to exceed two hundred fifty dollars (\$250.00);".
