As a condition of the distributions in paragraphs (b)(i) and (ii) of this section, for the period beginning on the effective date of this act and ending June 30, 2022, not later than June 15 and November 15 of each fiscal year, the municipality shall certify the amount of tax collected from the date of the prior distribution to the office of state lands and investments and the office of state lands and investments shall reduce the next distribution that would otherwise be provided to the municipality in accordance with this paragraph."

One-half (1/2) of this appropriation shall be distributed in fiscal year 2021 and one-half (1/2) of this appropriation shall be distributed in fiscal year 2022.".
