41-2-112. Wyoming water development program.

- (b) In developing financing recommendations under the Wyoming water development program, the commission shall:
- (iii) Recommend an allocation of project costs, including expenditures of state funds for Level I reconnaissance studies and Level II feasibility studies, to be reimbursed by project beneficiaries and to be borne by the state; Any allocation of project costs for Level I reconnaissance studies and Level II feasibility studies to be borne by the state shall not

exceed ninety percent (90%) of the total cost of the individual study provided
that:

(A) If a Level I study proceeds to a Level II study, the cost allocation amount to be reimbursed by the project beneficiaries for the Level I study shall carry over and apply towards the cost allocation amount to be reimbursed by the project beneficiaries for the Level II study; and

(B) If a Level I or Level II study proceeds to a Level III construction project, the cost allocation amount to be reimbursed by the project beneficiaries for a Level I or Level II study shall carry over and apply towards the loan or other funding sources requirement in W.S. 41-2-121(a)(ii)(E)(I).

41-2-121. Criteria for water development projects; disclosure of personal interests by commission.

- (a) The water development commission shall establish criteria for evaluation and administration of water development projects. Criteria shall include but not be limited to the following:
 - (ii) The commission's recommendation shall:
 - (E) Include financing methods subject to the following:

(I) Any water development <u>Level III construction</u> project may be financed by grants not to exceed seventy-five percent (75%) of the total cost of the project, <u>with the remaining funding to come from a loan through the commission or other funding sources and which shall include any funding obligations carried over pursuant to W.S. 41-2-112(b)(iii)(A) and (B);".</u>
