Page 1-lines 5 through 7 Delete entirely and insert "modifying the age and the combined age and service requirements for normal retirement benefits for general members hired after a specified date; modifying definitions; making conforming amendments;".

Page 1-line 8 Delete "providing for rulemaking;".

Page 1-line 9 Delete "effective dates" insert "an effective date".

Page 1-line 13 After "W.S." insert "9-3-402(a)(xxix)(intro), by creating a new paragraph (xxx) and by creating a new subsection (b),".

Page 1-lines 14 and 15 Delete entirely and insert "and (ii), by creating a new paragraph (iii), by renumbering (iii) as (iv) and by creating a new paragraph (v) are amended to read:".

Page 1-after line 15 Insert:

"9-3-402. Definitions.

(a) As used in this article:

(xxix) "General member initially employed after August 31, 2012" means a general member, other than a member meeting the provisions of subparagraph (B) of this paragraph, or paragraph (xxx) of this subsection, who:

(xxx) "General member initially employed after August 31, 2020" means a general member who meets the specifications in paragraph (xxix) of this subsection, except that the date of August 31, 2012 in that paragraph shall be August 31, 2020 and the date of September 1, 2012 shall be September 1, 2020 when applied to a "general member initially employed after August 31, 2020".

(b) For purposes of this article, "general member initially employed after August 31, 2012" shall include a "general member initially employed after August 31, 2020" except for purposes of W.S. 9-3-415(a)."

Page 5-lines 7 through 23 Delete entirely and insert:

"(i) Has at least four (4) years of service credit and is at least sixty (60) years of age and is not subject to paragraph (ii) or (iii) of this subsection; or

(ii) If a general member initially employed after August 31, 2012, and is not subject to paragraph (iii) of this subsection, has at least four (4) years of service credit and is at least sixty-five (65) years of age; or

(iii) If a general member initially employed after August 31, 2020, has at least four (4) years of service credit and is at least sixty-seven (67) years of age; or

(iii)-(iv) Has a combined total of years of service credit and years of age which equals at least eighty-five (85) and is not subject to paragraph (v) of this subsection;

(v) If a general member initially employed after August 31, 2020, has a combined total of years of service credit and years of age which equals at least ninety (90)."

"Section 2. This act is effective July 1, 2020."
