This appropriation shall be for the period beginning with the effective date of this act and ending June 30, 2022. This appropriation shall

not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2022. It is the intent of the legislature that this appropriation not be included in the office's standard budget for the immediately succeeding fiscal biennium.

(j) There is appropriated two hundred fifty thousand dollars (\$250,000.00) from the strategic investments and projects account created by W.S. 9-4-220(a) to the office of state lands and investments for expenses associated with any consulting services procured by the office as provided by this act. This appropriation shall be for the period beginning with the effective date of this act and ending June 30, 2022. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2022. It is the intent of the legislature that this appropriation not be included in the office's standard budget for the immediately succeeding fiscal biennium".
