Section 11. The state fair board shall pursue public-private partnership opportunities for the construction and operation of lodging facilities on the state fairgrounds. The Attorney General's Office shall advise the board regarding legal issues relating to the construction and operation of the privately funded facilities. Upon request of the board, the state building commission may direct the construction management department to assist the board in determining appropriate steps to undertake in constructing facilities on state owned property. If the board determines a public-private partnership is feasible, it shall recommend to the state building commission that the project be undertaken, specifying the recommended financing of the facility and related required infrastructure. The state building commission shall determine the feasibility of the project and if the commission determines the project is feasible, it shall submit its recommendations for the project, including recommended legislative authorization and any necessary appropriations as a separate component in its report to the legislature under W.S. 9-5-107(c). Upon the enactment of legislation authorizing the construction of the project, the state fair board may execute agreements as necessary to construct and operate the facilities and may expend funds as authorized. The department of agriculture is authorized to accept on behalf of the state fair board private funds of up to twelve million six hundred thousand dollars (\$12,600,000.00) to be used for the project. Any private funds accepted pursuant to this section shall be subject to an agreement executed by the department of agriculture, the state

fair board and the private party providing the funds. The agreement shall specify that the expenditure of the funds shall be subject to legislative authorization and that neither the state nor the state fair board shall be liable in any manner for failing to undertake the project. If legislative authorization is not provided for the project any funds accepted by the department of agriculture shall be returned, without interest, to the private party not later than March 31, 2021. Any agreement entered into pursuant to this section shall be subject to the approval of the attorney general.".
