1 (a) Not later than March 15 following each general 2 election, a select committee on tribal relations shall be 3 appointed subject to the following:

(i) The president of the senate shall appoint 5 three (3) members of the senate apportioned as nearly as 6 possible to reflect the percentage of the elected 7 8 membership of the majority and minority parties of the 9 senate, provided not more than two (2) of the members shall 10 be from the same political party. The president of the 11 shall designate a co-chairman of the select senate 12 committee;

(ii) The speaker of the house of representatives shall appoint three (3) members of the house apportioned as nearly as possible to reflect the percentage of the elected membership of the majority and minority parties of the house, provided not more than two (2) of the members shall be from the same political party. The speaker of the house shall designate a co-chairman of the select committee.

1 (i) Develop knowledge and expertise among its members regarding matters pertaining to Indian tribes in 2 3 the state and services and needs on the Wind River Indian 4 Reservation. Consideration of the topics in this paragraph 5 shall include health safety, water, education, and transportation, gaming, communications, law enforcement and 6 legal services, infrastructure, land and resources, 7 minerals, revenue, economic development and other issues 8 9 that are a concern to the residents on and near the Wind 10 River Indian Reservation as approved by management council; 11

(ii) Facilitate and foster communication and robust working relationships among state, tribal, federal and local entities and pursue opportunities for encouraging economic growth, nondiscrimination and wellbeing for residents of the Wind River Indian Reservation and neighboring communities;
