7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1.** W.S. 28-5-101(b) is amended to read:

- 11 28-5-101. Schedule of compensation, per diem and
- 12 travel expenses.

- 14 (b) <u>Until such time as the amount is adjusted as</u>
- 15 <u>provided in this subsection</u>, the amount to be received by
- 16 each member of the legislature for expenses shall be one

- 1 hundred nine dollars (\$109.00) one hundred fifty-one
- 2 <u>dollars (\$151.00)</u> per day. <u>The amount shall be adjusted as</u>
- 3 of July 1 each year by the state auditor to an amount equal
- 4 to the most recent standard per diem rate established by
- 5 the United States general services administration for
- 6 travel within Wyoming.

8 Section 2.

- 10 (a) There is appropriated five hundred thousand
- 11 dollars (\$500,000.00) from the general fund to the
- 12 legislative service office for purposes of supplementing
- 13 the per diem provided to legislators as required by this
- 14 act.

- 16 (b) There is appropriated fifty thousand dollars
- 17 (\$50,000.00) from the general fund to the state auditor's
- 18 office for purposes of supplementing the per diem provided
- 19 to members of any state board, commission, council,
- 20 authority or other state entity whose rate of per diem is
- 21 based upon the amount of per diem paid to legislators and

22 is paid from the general fund as required by this act.

1 (c) For members of any state board, commission,

2 council, authority or other state entity whose rate of per

3 diem is based upon the amount of per diem paid to

4 legislators and is paid from a nongeneral fund source, to

5 the extent funds are available, there is appropriated from

6 those accounts and funds to those entities amounts

7 necessary to supplement the per diem provided to those

8 members as required by this act.

9

10 (d) The appropriations under this section shall be

11 for the period beginning with the effective date of this

12 act and ending June 30, 2022. The appropriations under

13 this section shall not be transferred or expended for any

14 other purposes and any unexpended, unobligated funds

15 remaining from the appropriations under this section shall

16 revert as provided by law on June 30, 2022.

18 **Section 3.** This act is effective January 1, 2021.
