## "Section 3.

(a) Subject to subsection (b) of this section, there is appropriated five million dollars (\$5,000,000.00) from federal funds provided to the state through the Coronavirus Aid, Relief and Economic Security (CARES) Act, Public Law 116-136, to the supreme court for any emergency COVID-19 related expenses of the judicial branch of government that are consistent with the terms of the federal gift, grant or appropriation. Except as provided in this section, this

appropriation shall not be transferred or expended for any other purpose. Any unexpended, unobligated funds remaining from this appropriation on December 30, 2020 shall revert as provided by law.

(b) On or before September 15, 2020, the supreme court shall estimate the total amount of funds expended, obligated or necessary to address COVID-19 related expenses and expenditures of the judicial branch. Any funds in excess of the total amount estimated by the supreme court under this subsection may be transferred to the office of the governor and are hereby reappropriated for the purposes specified in section 2 of this act. Funds reappropriated under this subsection shall be subject to any limitation provided in section 2 of this act.

## Section 4.

(a) Subject to subsection (b) of this section, there is appropriated five million dollars (\$5,000,000.00) from federal funds provided to the state through the Coronavirus Aid, Relief and Economic Security (CARES) Act, Public Law 116-136, to the legislative service office for any emergency COVID-19 related expenses of the legislative branch of government that are consistent with the terms of the federal gift, grant or appropriation. Except as provided in this section, this appropriation shall not be transferred or expended for any other purpose. Any unexpended, unobligated funds remaining from this appropriation on December 30, 2020 shall revert as provided by law.

(b) On or before September 15, 2020, the management council of the legislature shall estimate the total amount of funds expended, obligated or necessary to address COVID-19 related expenses and expenditures of the legislative branch. Any funds in excess of the total amount estimated by the management council of the legislature under this subsection may be transferred to the office of the governor and are hereby reappropriated for the purposes specified in section 2 of this act. Funds reappropriated under this subsection shall be subject to any limitation provided in section 2 of this act."

### "Section 2.

Subject to the limitations provided in subsections (b) through (e) (a) section, up to one billion two hundred million dollars of this (\$1,200,000,000.00) of federal funds provided to the state for COVID-19 related purposes including from the Coronavirus Aid, Relief and Economic Security (CARES) Act, Public Law 116-136, or other similarly purposed federal act that do not accrue to any agency under W.S. 9-2-1006(a) are appropriated to the department of revenue for distribution to individuals and families who have been economically impacted by the public health crisis, consistent with the terms of the federal gift, grant or appropriation and as specified in this section. Upon application and certification on a form created by the department of revenue that an individual was a resident of Wyoming on March 1, 2020, continues to be a Wyoming resident and has been impacted financially by the COVID-19 public health crisis, the department shall distribute a direct impact payment of two thousand dollars (\$2,000.00) to the applicant.

(b) All distributions authorized in subsection (a) of this section shall be distributed not later than August 15, 2020.

(c) The department of revenue shall promulgate emergency rules and shall create the application necessary to carry out the distributions authorized in subsection (a) of this section in a timely and efficient manner for all Wyoming residents. The application and distributions authorized under subsection (a) of this section may include use of electronic application and distribution systems.

(d) The attorney general shall review the department of revenue's emergency rules and application form to ensure the legality of the plans for the distributions authorized under subsection (a) of this section.

(e) In authorizing the distributions in subsection (a) of this section, the legislature finds that due to the extraordinary economic devastation caused by COVID-19, these payments constitute targeted fiscal and monetary policy that will return adequate consideration to the state through stimulus to the Wyoming economy, provide necessary support of the poor in an efficient manner and help fulfill the state's moral obligation to all residents who are impacted by business closures.".
