**Health care professional education endowment.**

Sponsored By: Representative(s) Harshman, Connolly, MacGuire, Walters, Washut and Zwonitzer and Senator(s) Furphy, Landen and Wasserburger

AN ACT relating to health care education; creating an inviolate health care education endowment fund; providing for investment of monies in the fund; providing for distribution of monies; providing for the use of earnings for the support of certain health care education programs at the University of Wyoming and Wyoming community colleges or the western interstate commission for higher education professional student exchange program; authorizing the use of earnings for student support payments and administrative costs; specifying goals; creating a board; requiring rulemaking; generally providing for administration of the act; providing a continuous appropriation; providing for consideration of an additional supplemental appropriation; and providing for an effective date.

(i) First, fifty-five million dollars (\$55,000,000.00) to the Wyoming front line health care education endowment fund created in sections 1 and 2 of this act;

(ii) After the full appropriation in paragraph (i) has been deposited, five million dollars (\$5,000,000.00) to the Wyoming front line health care education endowment reserve account created in section 2 of this act.

(b) To the extent the full appropriations in subsection (a) of this section cannot be made in any single year, the remainder of the appropriations shall be made at the end of subsequent fiscal years from the legislative

stabilization reserve account as funds are available above the balance specified in subsection (a).".
