- (i) Identification of the buildings, facilities, landscapes, lots, premises or structures owned by the university to which any water line, system,

well or works operated, maintained or used by the university should be connected;

- (ii) The anticipated savings by the university by being able to independently facilitate the distribution and use of water;
- (iii) The impact to the water supply of the city of Laramie and the estimated costs to the state of Wyoming for a groundwater interference study.". $\ensuremath{\mathsf{BEAR}}$
