ARTICLE 17

HIGHER EDUCATION EXPENDITURES ON ABORTIONS

# 21-16-1701. Prohibition on expending funds for abortion.

(a) As a condition of receiving or expending any monies or funds appropriated to the University of Wyoming, the University of Wyoming shall not expend any general funds, federal funds or other funds under its control for:

(i) Elective abortions for students;

(ii) Group health insurance that provides coverage of elective abortions for students.

(b) As a condition of receiving any monies or funds appropriated to the community college commission, a community college shall not expend any funds for:

(i) Elective abortions for students;

(ii) Group health insurance that provides coverage of elective abortions for students.". ZWONITZER
