Nothing herein shall contravene the discretion of cities and towns to deny connection to the municipal sewerage system.
- (b) As used in this section, "affordable housing" means residential housing that is rented to or owned by a person who qualifies as a low-income or moderate-income household, however defined.". SOMMERS
