9 **Section 1**. W.S. 6-8-105 is created to read:

- 11 6-8-105. Exceptions for state issued concealed carry
- 12 permits.

14 (a) This section shall be known as and may be cited

15 as the "Wyoming Repeal Gun Free Zones Act".

3 Wyoming under W.S. 6-8-104(a)(ii) through (iv) may carry a

4 concealed weapon in the following places:

6 (i) Any meeting of a governmental entity;

8 (ii) Any meeting of the legislature or a

9 committee thereof.

11 (c) Persons lawfully carrying concealed weapons in

12 Wyoming under W.S. 6-8-104(a)(ii) or (iii) may carry a

13 concealed weapon in the following places:

15 (i) Any public school, public college or

16 university or professional athletic event, except as

17 provided in W.S. 21-3-132;

19 (ii) Any public elementary or secondary school

20 facility, except as provided in W.S. 21-3-132;

- 3 (i) Allow the carrying of a concealed weapon
- 4 where otherwise prohibited under W.S. 6-8-104(t);

- 6 (ii) Prohibit a school district from regulating

- 8 district on school property under W.S. 21-3-132;

- 10 (iii) Prohibit a private property owner from
- 11 restricting firearms on his private property.

- 14 6-8-403(a)(vii) are amended to read:

- 19 (t) Except as provided in W.S. 6-8-105, no person
- 20 authorized to carry a concealed weapon pursuant to

2 and prohibition by state.

4 (c) The sale, transfer, purchase, delivery, taxation, 5 manufacture, ownership, transportation, storage, use and possession of firearms, weapons and ammunition shall be 6 authorized, regulated and prohibited by the state, and 7 regulation thereof is preempted by the <u>legislature of the</u> 8 9 state of Wyoming. Except as authorized by W.S. 10 15-1-103(a)(xviii) and 21-3-132, no state agency or entity, city, town, county, political subdivision or any other 11 12 entity shall authorize, regulate or prohibit the sale, 13 transfer, purchase, delivery, taxation, manufacture, 14 ownership, transportation, storage, use, carrying or 15 possession of firearms, weapons, accessories, components or 16 ammunition except as specifically provided by this chapter. 17 This section shall not affect zoning or other ordinances which encompass firearms businesses along with other 18 19 businesses. Zoning and other ordinances which are designed 20 for the purpose of restricting or prohibiting the sale, 21 purchase, transfer or manufacture of firearms or ammunition as a method of regulating firearms or ammunition are in 22 23 conflict with this section and are prohibited.
