# State investments-compensation and relocation amendments.

Sponsored By: Select Committee on Capital Financing & Investments

AN ACT relating to the administration of government; amending performance compensation payment limits for senior analysts and analysts employed by the state treasurer and the Wyoming retirement system; authorizing relocation expenses for investment staff hired by the state treasurer and the Wyoming retirement system; establishing maximum compensation amounts for investment staff employed by the state treasurer and the Wyoming retirement system; providing appropriations; and providing for an effective date.

## "Section 2.

- (a) There is appropriated three hundred ninety-five thousand two hundred seventy-six dollars (\$395,276.00) from funds that would otherwise be deposited to the general fund from investment earnings to the state treasurer's office for purposes of this act. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation on June 30, 2025 shall revert as provided by law.
- (b) There is appropriated two hundred eighty-four thousand six hundred sixty-four dollars (\$284,664.00) from the retirement account created by W.S. 9-3-407(a) to the Wyoming retirement system for purposes of this act. This appropriation shall not be transferred or expended for any other purpose and

any unexpended, unobligated funds remaining from this appropriation on June 30, 2025 shall revert as provided by law.".
