(III) First aid and cardiopulmonary resuscitation training and certification. The employees and director or owner shall maintain current certification under this subdivision; and

(G) Upon enrollment of a child, discloses to the parents or guardians that the facility is not licensed and does not adhere to the regulations of the Wyoming department of family services pursuant to W.S. 14-4-104." BALDWIN
