Department authorized license plates and annual stickers shall be of colors that are readily distinguishable from the previous year.".

(m) Fifty percent (50%) of the permanent registration fee collected under W.S. 31-2-206(n) shall be distributed by county treasurers in the same proportion and manner as property taxes are distributed. The remaining fifty percent (50%) of the permanent registration fee collected under W.S. 31-2-206(n) shall be distributed to the highway fund.". BONER, CHAIRMAN
