

HB0116 Prohibiting foreign property ownership in Wyoming.

AN ACT relating to property; restricting foreign ownership of land and other interests in Wyoming as specified; defining terms; requiring registration as specified; authorizing enforcement of ownership restrictions as specified; providing a civil penalty; requiring the inclusion of notices of foreign ownership in assessment schedules and tax statements; specifying applicability; requiring rulemaking; and providing for an effective date.

This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2024. It is the intent of the legislature that this appropriation shall not be included in the secretary of state's office budget for the immediately succeeding fiscal biennium.".

(a) There is appropriated five million dollars (\$5,000,000.00) from the general fund to the secretary of state's office for purposes of administering this act or for establishing grants to counties for purposes of administering this act. This appropriation shall be for the period beginning with the effective date of this act and ending June 30, 2026. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026. It is the intent of the legislature that this appropriation shall not be included in the secretary of state's office budget for the 2027-2028 fiscal biennium.

(b) There is appropriated one hundred million dollars (\$100,000,000.00) from the legislative stabilization reserve account to the state auditor's office to be held in a separate account which is hereby created. Funds in the account shall only be appropriated to provide funding for monetary judgments rendered against the state of Wyoming in a court of competent jurisdiction in an action which arose as a result of the state or a political subdivision of the state enforcing the provisions of W.S. 34-15-114(b) as created by this act. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026. It is the intent of the legislature that this appropriation shall not be included in the state auditor's office budget for the 2027-2028 fiscal biennium.".

Page 8-lines 18 and 19 Delete entirely.
