"(b) The <u>per diem</u> amount to be received by each member of the legislature and persons receiving per diem pursuant to this section as provided by law for expenses shall be <u>one hundred nine dollars (\$109.00) per day.</u> <u>equal to an amount</u> to be determined on July 1 of each year by the state auditor that is equal to the most recent per diem rates established by the United States general services administration for locations within Wyoming except that:".

(i) The amount shall be reduced by thirty percent (30%) for each member of the legislature when the legislature is in session except, as provided in paragraph (ii) of this subsection;

(ii) The amount shall be reduced by seventy-five percent (75%) for each member of the legislature whose primary residence is not greater than twenty-five (25) miles from the location where a committee meeting or session of the legislature is held that the legislator attends and for which he receives per diem under this section.". Such written notice shall be a public record.".
