(ii) Where the slow moving vehicle emblem on the towing unit is not obscured by the towed unit or its load, then either ox both may shall be equipped with the required emblem but it shall be sufficient if either has it -a slow moving vehicle emblem and a speed identification symbol, as determined by the manufacturer;
(iii) Any combination of towing unit shall not travel at speeds in excess of the lowest speed indicated by a speed identification symbol displayed on any portion of the towed unit or its load. If only a slow moving vehicle emblem is displayed on any towed unit or any load then the towing unit shall not travel at speeds in excess of twenty-five (25) miles per hour.
