(e) Every combination of farm tractor and towed farm equipment or towed implement of husbandry or units towed by special mobile equipment normally operating at speeds not in excess of twenty-five (25)-forty-five (45) miles per hour shall at all times be equipped with a slow moving vehicle emblem as follows:".

"(i) Where the towed unit or any load thereon obscures the slow moving vehicle emblem on the towing unit, the towed unit shall be equipped with a slow moving vehicle emblem and a speed identification symbol, as determined by the manufacturer. In such cases, the towing vehicle need not display the emblem;

(ii) Where the slow moving vehicle emblem on the towing unit is not obscured by the towed unit or its load, then either or both may shall be equipped with the required emblem but it shall be sufficient if either has it \div a slow moving vehicle emblem and a speed identification symbol, as determined by the manufacturer;

(iii) Any combination of towing unit shall not travel at speeds in excess of the lowest speed indicated by a speed identification symbol displayed on any portion of the towed unit or its load. If only a slow moving vehicle emblem is displayed on any towed unit or any load then the towing unit shall not travel at speeds in excess of twenty-five (25) miles per hour.
