- (b) Notwithstanding W.S. 9-2-1008 and 9-4-207, of unexpended, unobligated monies appropriated from water development account I in 2022 Wyoming Session Laws, Chapter 51, Section 2, Section 037, to the state engineer, board of control program, up to three million five hundred sixty-four thousand seven hundred seven dollars (\$3,564,707.00) or as much thereof as is available shall revert to water development account I not later June 30, 2023.
- (c) There is appropriated twelve thousand four hundred seventy-seven dollars (\$12,477.00) from the general fund to the state engineer for the administration program. This appropriation shall not be transferred or expended for any other purpose.
- (d) Notwithstanding W.S. 9-2-1008 and 9-4-207, of unexpended, unobligated monies appropriated from water development account I as created by W.S. 41-2-124(a)(i)in 2022 Wyoming Session Laws, Chapter 51, Section 2, Section 037, to the state engineer, administration program, up to twelve thousand four hundred seventy-six dollars (\$12,476.00) or as much thereof as is available shall revert to water development account I not later than June 30, 2023.
- (e) Any funds appropriated to the state engineer, board of control program and the administration program from the general fund in 2023 House Bill 0093, as enacted, shall be reduced by one dollar (\$1.00) for every one dollar (\$1.00) appropriated and any reduction in funds appropriated from water development account I by 2023 House Bill 0093 shall be increased by one dollar (\$1.00) for every one dollar (\$1.00) reduced. These appropriations shall be given precedence and prevail over any appropriations to the state engineer, board of control program and the administration program by 2023 House Bill 0093.".
