9 Be It Enacted by the Legislature of the State of Wyoming:

- 11 **Section 1**. W.S. 19-9-403 by creating a new subsection
- 12 (e) is amended to read:

- 14 19-9-403. Pay and allowances of officers and enlisted
- 15 persons in active state service and state active duty;

1 worker's compensation coverage for national guard members; no pension denied by reason of service; Wyoming national

3 guard member referral incentive program.

5 (e) There is created the Wyoming national guard 6 member referral incentive program. The purpose of the 7 program shall be to incentivize and maximize peer-to-peer 8 recruiting that results in a completed accession to the Wyoming national guard by providing a referral bonus to 9 10 Wyoming national guard members who make a successful 11 referral. Administration of this program shall require 12 that:

(i) A Wyoming national guard member may provide the identity and contact information of a person who the member believes would be an appropriate recruitment prospect using a form provided by the Wyoming national guard, which includes the person's name, contact information and any other information required by the military department;

(ii) The military department shall keep a record 22 23 of all forms submitted under paragraph (i) of this

subsection. Upon the completed accession of a referred 2 person and to the extent sufficient funds are available, 3 the military department shall distribute a referral bonus 4 to the member who provided the successful referral; 5 (iii) Beginning July 15, 2024 and annually every 6 7 July 15 thereafter, the Wyoming military department shall 8 report regarding the Wyoming national guard member referral incentive program to the joint transportation, highways and 9 10 military affairs interim committee and shall include in the 11 report the number of referral forms submitted, the number of successful referrals, the amounts of referral bonuses 12 paid and any recommended legislation; 13 14 15 (iv) As used in this subsection: 16 17 (A) "Completed accession" means the referred person signs the referred person's name to an 18 19 enlistment contract for entry or re-entry after prior 20 service into the Wyoming national guard; 21

1	(B) "Referral bonus" means a monetary
2	payment set each calendar year by the adjutant general not
3	to exceed five hundred dollars (\$500.00);

5	(C) "Successful referral" means providing
6	the identity and contact information pursuant to paragraph
7	(e)(i) of this subsection of any person not already a
8	member of the Wyoming national guard that results in a
9	completed accession to the Wyoming national guard.

11	(v) This subsection is repealed effective July
12	<u>1, 2026.</u>

14	Section 2.

16	(a) The Wyoming military department is authorized
17	one-half (1/2) full-time equivalent position for the
18	purpose of implementing and administering this act. There
19	is appropriated from the general fund one hundred
20	forty-four thousand dollars (\$144,000.00) to the military
21	department for purposes of paying the salary and benefits
22	of the employee authorized under this subsection. This
23	appropriation shall be for the period beginning with the

3 other purpose and any unexpended, unobligated funds

4 remaining from this appropriation shall revert as provided

5 by law on June 30, 2026. It is the intent of the

8 budget request if the Wyoming national guard member

12 (b) There is appropriated eight hundred thousand dollars (\$808,000.00) from the general fund to the 13 Wyoming military department for the purposes of making the 14 15 authorized by cash bonus payments this act. This 16 appropriation shall be for the period beginning with the 17 effective date of this act and ending June 30, 2026. This appropriation shall not be transferred or expended for any 18 19 unexpended, unobligated purpose and any 20 remaining from this appropriation shall revert as provided 21 by law on June 30, 2026. It is the intent of the 22 legislature that the appropriation in this subsection be included in the military department's 2027-2028 standard 23
