A BILL

for

1 AN ACT relating to local government funding; increasing a
 2 prior appropriation; making conforming changes to the
 3 related formulas; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** 2022 Wyoming Session Laws, Chapter 91,
 8 Section 1(a)(intro), (b)(intro) and (c)(intro) is amended
 9 to read:

13 (a) From the general fund there is
 14 appropriated ~~one hundred five million dollars~~
 15 ~~(\$105,000,000.00)~~ one hundred eighteen million
 16 one hundred twenty five thousand dollars

1 (\$118,125,000.00) to the office of state lands
2 and investments ~~to~~ as provided in this
3 subsection. Fifty-two million five hundred
4 thousand dollars (\$52,500,000.00) shall be
5 available in the first fiscal year of the
6 biennium and sixty-five million six hundred
7 twenty-five thousand dollars (\$65,625,000.00)
8 shall be available in the second fiscal year of
9 the biennium. The appropriation shall be
10 allocated pursuant to the following and as
11 further provided in this section:

13 [CITY AND TOWN DIRECT DISTRIBUTION ALLOCATIONS]

15 (b) Funds appropriated in paragraphs (a)(i)
16 and (iii) of this section shall be distributed to
17 cities and towns ~~with one-half (1/2) of~~ based on
18 the amount ~~available distributed in the first~~
19 appropriated for each fiscal year of the biennium
20 ~~and one-half (1/2) of the amount available~~
21 ~~distributed in the second fiscal year of the~~
22 biennium under subsection (a) of this section.

23 Distributions in each fiscal year shall be made

1 in equal amounts on August 15 and January 15 of
2 each fiscal year as calculated prior to the
3 August 15 distribution, subject to the following:

7 (c) Funds appropriated in paragraphs
8 (a)(ii) and (iv) of this section are to be
9 distributed to counties ~~with one-half (1/2) of~~
10 ~~based on~~ the amount ~~available distributed in the~~
11 ~~first appropriated for each~~ fiscal year of the
12 biennium ~~and one-half (1/2) of the amount~~
13 ~~available distributed in the second fiscal year~~
14 ~~of the biennium~~ under subsection (a) of this
15 section. Distributions in each fiscal year shall
16 be made in equal amounts on August 15 and January
17 15 of each fiscal year as calculated prior to the
18 August 15 distribution. From these distributions
19 each county shall receive the following:

1 **Section 2.** This act is effective immediately upon
2 completion of all acts necessary for a bill to become law
3 as provided by Article 4, Section 8 of the Wyoming
4 Constitution.
