1 (a) The director or a local authority may designate 2 any roadway, part of a roadway or specific lane of a 3 roadway under the director's or local authority's 4 jurisdiction as a high occupancy vehicle lane. 5 (b) A vehicle operating in a high occupancy vehicle 6 7 lane shall be a high occupancy vehicle except: 8 9 (i) Motorcycles, bicycles and public 10 transportation vehicles may operate in a high occupancy vehicle lane regardless of the number of occupants, subject 11 12 to the other requirements under this act; 13 14 (ii) Any vehicle making a turn from a high occupancy vehicle lane, subject to the other requirements 15 16 under this act. 17 (c) The department shall implement rules to provide 18 19 for the design, operation, maintenance and required signage 20 for high occupancy vehicle lanes. 21 22 (d) Any person who operates a vehicle in a high
