8 Be It Enacted by the Legislature of the State of Wyoming:

10 Section 1. W.S. 16-6-122 is created to read:

12 16-6-122. Public works contracts and grants;

- 1 (a) The legislature finds that the intent of this
- 2 section is to provide for more economical,
- 3 nondiscriminatory, neutral and efficient procurement of
- 4 construction related services by governmental entities. The
- 5 legislature further finds that enabling fair and open
- 6 competition best effectuates this intent.

- 8 (b) A governmental entity that awards or renews a
- 9 contract on or after July 1, 2023, for a construction
- 10 related project regarding a facility the governmental
- 11 entity owns or leases directly or through a building
- 12 authority, shall not include any of the following terms in
- 13 any contract related document a term that:

14

- 15 (i) Requires, prefers or prohibits a bidder,
- 16 offeror, contractor or subcontractor from entering into or
- 17 adhering to an agreement with a labor organization in
- 18 regard to the construction related project;

- 20 (ii) Otherwise discriminates against a bidder,
- 21 offeror, contractor or subcontractor for being, becoming or
- 22 refusing to become or remain a signatory to, or for
- 23 adhering or refusing to adhere to, an agreement with a

1 labor organization in regard to the construction related

2 project.

4 (c) A governmental entity shall not award or renew a

5 grant for a construction related project that is

6 conditioned on the recipient including a term prohibited by

7 subsection (b) of this section in a contract related

8 document concerning a facility or real property that is the

9 subject of the grant.

11 (d) The head of a governmental entity may exempt a

12 contract related document or grant from the requirements of

13 subsection (b) or (c) of this section, as applicable, if

14 the governmental entity finds that the exemption is

15 necessary to avert an imminent threat to public health or

16 safety.

18 (e) As used in this section:

20 (i) "Construction related project" includes the

21 construction, improvement, maintenance, expansion, repair,

22 renovation, remodeling or demolition of a facility;

1 (ii) "Contract related document" includes a bid 2 specification, project agreement or other controlling 3 document for a construction related project; 4 (iii) "Facility" means: 5 6 7 (A) A highway, road, bridge, runway or 8 rail; 9 (B) A building or structure along with its 10 grounds, approaches, services, fixtures and appurtenances; 11 12 13 (C) Any other similar physical improvement 14 to real property. 15 (iv) "Governmental entity" means the University 16 17 of Wyoming, the state, any department thereof, and any county, city, town, school district, community college 18 19 district, other political subdivision and other public 20 corporation of the state. 21

1 Section 2. This act is effective July 1, 2023.
