The review and analysis shall seek to identify risks or problems that may have a substantial impact on either electricity rates or the ability to use the facility in question for other purposes. The department of environmental quality shall conduct the initial review and analysis with existing staff and resources. If appropriate, the department shall recommend any further investigation and study need related to potential problems."
