## A BILL

for

- 1 AN ACT relating to game and fish; authorizing the Wyoming
- 2 game and fish commission to regulate commercially guided
- 3 fishing boats; providing for registration of commercially
- 4 guided fishing boats, vehicles and trailers operated by
- 5 outfitters and professional fishing guides; providing
- 6 definitions; providing rulemaking authority; and providing
- 7 for an effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

11 **Section 1**. W.S. 23-3-206 is created to read:

23-3-206. Commercially guided fishing boats;

1 (a) To protect the quality of the fishing experience,

2 the fishery and other aquatic resources and species in this

3 state, the commission may set limits on the number of

4 commercially guided fishing boats allowed to launch into

5 any river or lake or section thereof.

6

(b) In the event that the commission sets limits on 7 the number of commercially guided fishing boats allowed to 8 launch into any river or lake or section thereof, the 9 10 shall promulgate rules governing commission the registration and of tracking the number 11 means of 12 commercially guided fishing boats launching into any river or lake or section thereof. In addition to requirements 13 under the Administrative Procedure Act, the commission 14 shall hold public meetings in each community in which the 15 rules apply. The rules shall require registration and 16 17 payment of an annual fee for each commercially guided fishing boat and vehicle or trailer that is operated by an 18 19 outfitter or professional fishing guide and that 20 operated during any period of time during a year in any river or lake or section thereof for which the commission 21 has set limits. A registration sticker shall be displayed 22

- 1 on each commercially guided fishing boat and on each
- 2 vehicle or trailer registered under this subsection.

4 (c) As used in this section:

- 6 (i) "Commercially guided fishing boat" means a
- 7 fishing boat that is operated by an outfitter or
- 8 professional fishing guide to provide fishing guide
- 9 services for financial gain;

10

- 11 (ii) "Fishing guide services" means for hire or
- 12 remuneration, accompanying and providing assistance to a
- 13 person on a river or lake for the purposes of fishing;

14

- 15 (iii) "Operate" means to navigate or otherwise
- 16 use a watercraft;

- 18 (iv) "Outfitter" or "professional fishing guide"
- 19 means a person who advertises or holds himself out to the
- 20 public for hire for the purpose of financial gain to
- 21 provide fishing guide services, excluding any person who
- 22 furnishes fishing equipment to a person for exclusively
- 23 personal and temporary use. "Outfitter" or "professional

1 fishing guide" includes any person requiring the payment of

2 dues or remuneration for providing personal services on a

3 river or lake for the purposes of fishing.

4

5 Section 2. This act is effective July 1, 2024.
