1 (a) The following persons when practicing within the

2 scope of their authority and their education and training

3 may engage in acts included in the definition of the

4 practice of behavior analysis under W.S. 33-27-113(a)(xiii)

5 without being licensed as a behavior analyst or assistant

6 behavior analyst under this act:

8 (viii) A behavior technician who delivers 9 behavior analysis services under the supervision of a 10 licensed behavior analyst or licensed assistant behavior analyst. A behavior technician shall not represent himself 11 12 as a licensed behavior analyst or licensed assistant 13 behavior analyst and shall only use titles that communicate his unlicensed status, such as "applied behavior analysis 14 technician, " "behavior technician" or "tutor. " As used in 15 16 paragraph, "behavior technician" paraprofessional who practices under the supervision of a 17 licensed behavior analyst or licensed assistant behavior 18 19 analyst and who delivers services as assigned by the 20 supervisor responsible for the technician's work or a 21 caregiver or family member of a recipient of behavior 22 analyst services who delivers services to a recipient under 23 the supervision of and has been properly trained by a

2 <u>analyst</u>. The services that may be assigned to a behavior

3 technician shall not include designing assessment or

4 intervention plans or procedures;

6 (ix) A caregiver <u>or family member</u> of a recipient
7 of behavior analysis services who delivers behavior

8 analysis services to the recipient under the authority and

9 direction of a licensed behavior analyst or licensed

10 assistant behavior analyst. The caregiver or family member

11 shall not represent themselves as a licensed behavior

12 analyst or licensed assistant behavior analyst under this

13 paragraph and shall deliver behavior analysis services only

14 to the person who is receiving behavior analysis services

15 from the licensed behavior analyst or licensed assistant

16 behavior analyst who is supervising the caregiver or family

17 member; or

19 **Section 2.** The board of psychology shall promulgate

20 all rules necessary to implement this act.
