A BILL

for

1 AN ACT relating to education; specifying that students must
2 take either fine and performing arts or career and
3 technical education as a part of the Hathaway success
4 curriculum; and providing for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 21-16-1307(b)(intro), by creating a
9 new paragraph (vi), (d)(intro), by creating a new paragraph
10 (vi), (e)(intro) and by creating a new paragraph (iii) is
11 amended to read:

13 **21-16-1307. Success curriculum; test standards.**

1 (b) The success curriculum required to qualify for
2 honor or performance scholarship eligibility under this
3 article for students graduating from high school in the
4 2010-2011 school year and each school year thereafter shall
5 be as follows:

7 (vi) Effective in the 2013-2014 school year and
8 each school year thereafter, one (1) of the following:

9
10 (A) Fine and performing arts - one (1) year
11 of instruction in fine and performing arts, which shall be
12 taken in grades nine (9) through twelve (12); or

13
14 (B) Career-vocational education - one (1)
15 year of instruction in career and technical education,
16 which shall be taken in grades nine (9) through twelve
17 (12).

19 (d) The success curriculum required to qualify for
20 opportunity scholarship eligibility under this article for
21 students graduating from high school in the 2010-2011
22 school year and each school year thereafter shall be as
23 follows:

(vi) Effective in the 2013-2014 school year and

each school year thereafter, one (1) of the following:

(A) Fine and performing arts - demonstrate

proficiency on the state standards for the fine arts and

performing arts common core of knowledge requirement under

W.S. 21-9-101(b)(i)(E); or

(B) Career-vocational education -

demonstrate proficiency on the state standards for the

career/vocational education common core of knowledge

requirement under W.S. 21-9-101(b)(i)(J).

(e) The success curriculum required to qualify for

provisional opportunity scholarship eligibility under this

article for students graduating from high school in the

18

2010-2011 school year and each school year thereafter shall

be the curriculum required for high school graduation under

W.S. 21-2-304(a)(iii) subject to the following:

1 (iii) Effective in the 2013-2014 school year and
2 each school year thereafter, demonstration of proficiency
3 on the state standards for:

5 (A) The fine arts and performing arts
6 common core of knowledge requirement under W.S.
7 21-9-101(b)(i)(E); or

9 (B) The career-vocational education common
10 core of knowledge requirement under W.S. 21-9-101(b)(i)(J).
