




Biennium 2015-2016 Monthly Title 25 Costs, through 5.31.16



WDH Title 25 Costs, by provider, SFY 2010-2016






WDH Title 25: Expenses vs Budget, SFY 2010-2016




WDH Title 25: monthly and cumulative costs

through 4.30.16



SF 58 Summary



Senate File 58 (Enrolled Act 56):

- Created W.S. §25-10-110.1
 - Allows courts to issue orders for "Directed Outpatient Commitment"
 - Alternative to involuntary hospitalization
 - Provides guidelines to courts and treatment providers
 - Requires WDH to promulgate rules for its treatment providers
- Allows WDH to designate Title 25 "Gatekeepers"
 - In consultation with county commissions
 - Permitted, not required (pilot programs)
 - Provides guidelines and expectations for "gatekeepers"
- Title 25 Statute cleanup
 - Payments (§25-10-112)
 - Convalescent leave
 - Designated hospitals

SF 58 Implementation



Directed Outpatient Commitment

- Issuing notice to promulgate rules for WDH providers ("treatment providers")
- Issuing policy guidance to courts, treatment providers, counties, and other stakeholders (during rule promulgation)
- WDH and CMHC application for federal grant for directed outpatient infrastructure development (\$1m/year)

Gatekeepers

- Working with select counties on gatekeeping contracts
- Delayed pending results of required budget reductions
- Community mental health center contract re-alignments

Community Mental Health: Payment Reform



- Began January 6, 2016
- WDH developed payment reform work groups:
 - WDH staff
 - o CMHC/SACs
 - Consumers/advocates
 - Other stakeholders
- Purpose: to better align services and payments with the needs and risks of priority populations (i.e., Title 25)

Work Groups

- o Data
- Priority Populations
- Services/Service Delivery
- Business/Operations

Meetings

- Monthly (physical and virtual attendance)
- Facilitated by WDH staff and CMHC staff (co-chairs)
- o Products:
 - ▼ Develop policy recommendations to WDH leadership on final payment reform model
- Target Completion: June 2017

Title 25 Payment System Changes



- Worked with Medicaid vendor to build new system for processing Title 25 payments
- All "claims" from designated hospitals will be sent through the MMIS (Medicaid data system)
- Advantages:
 - Granular data
 - Flexibility in Title 25 fiscal policy
 - System determines pay source (FMAP or SGF only)
- Launch: August 1, 2016
