Agenda

The Committee will meet to continue its work on interim topics. The Committee will receive testimony from the Department of Insurance regarding the continuing operation and impacts of the Affordable Care Act (ACA) in Wyoming, the status of Wyoming's health insurance marketplace, the potential for an ACA §1332 waiver to address rising health insurance costs and federal actions impacting insurance regulation. The Committee will receive testimony from the Department of Health regarding long-term health care, the reporting of confidential information under Wyoming's Adult Protective Services Act and the Child Health Insurance Program. The Committee also will receive an update from the Department of Health Facilities Task Force and discuss health care professional training and shortages. Finally, the Committee will receive information from the Department of Workforce Services and others on seasonal employment. During the meeting, the Committee expects to review draft legislation concerning: potential authorization for a Section 1332 waiver under the ACA; the coverage of real estate professionals under Wyoming's unemployment compensation statutes; the reporting of confidential information under Wyoming's Adult Protective Services Act; criminal conviction status in professional licensing and employment; nonresident employer bonding; and obsolete Department of Workforce Services reporting requirements. The Committee will invite public comment on each topic.
